3. Orientation to the District and Campus Procedures for Strategic Planning

Dr. Robert Bayard reviewed the following items from the document:

Dr. Robert Bayard then introduced each DEIC sub-committee facilitator to give a brief description of the purpose of the sub-committees.

- Budgeting/Staffing: the sub-committee reviews budgetary and staffing data and makes recommendations based on this information. This sub-committee meets 1-2 times during the year and is facilitated by Alice Benzaia
- Calendar: the sub-committee reviews various calendar models and makes a recommendation based on the best needs of students. This sub-committee will meet 2-3 times during the first semester and is facilitated by Dr. Susan Silva.
- Technology: the sub-committee advises the Chief Technology Officer on a wide variety of topics around learning technology. Committee members also assist with the review of the district technology. This sub-committee meets 1-2 times during the year and is facilitated by Dustin Hardin.
- Planning: the sub-committee reviews data such as student assessment results, student demographic information, and community survey results. This data is used to revise the District Strategic Action Plans. The sub-committee meets 2-3 times per year and is facilitated by Dr. Robert Bayard.
- Professional Learning: the sub-committee reviews the District Professional Learning Plan, as well as provides input regarding professional learning initiatives associated with the District Strategic Plan. This sub-committee meets 1-2 times per year and is facilitated by Angela Hinkelman.
