2022 SCHOOL SAFETY ADVISORY COMMITTEE

Recommendations Report

July 2022

BACKGROUND

The Clear Creek Independent School District convened a School Safety Advisory Committee during the summer of 2022 to review current safety measures in place and to make recommendations to the Superintendent on areas of improvement in the wake of the school shooting in Uvalde, Texas. The committee is comprised of parents, students, staff, law enforcement and community leaders. The committee met four times. The committee roster and meeting presentations are enclosed.

The group was guided by the following charges and guidelines:

- Recommend appropriate changes and timelines to ensure a safe and nurturing learning environment for students and staff
- Review current practices and policies and determine the level of fidelity in implementation
- Identify sources of funding from Federal, State and Local levels to support recommendations including both fixed assets and personnel
- Identify, investigate, and address causal factors for students in crisis

The District issued a public input forum to solicit community perceptions of school safety and ideas of how to improve the physical and emotional safety of students. The entire report is enclosed.

The three major themes which emerged from community feedback were:

- School Security Staffing
- Identifying and Responding to Threats
- Technology and Security Systems

The committee discussed, in small and large group settings, these topics and the following reflect their recommendations and aspirations over time for the Clear Creek Independent School District. These recommendations are provided to the Superintendent for consideration and further action.

SCHOOL SECURITY STAFFING

The Clear Creek Independent School District, following the school shooting in 2018 at Santa Fe High School, significantly increased staffing for school liaison officers. As part of the security staffing plan, 15 additional officers were hired. The additional officers allowed CCISD to place a third officer at each comprehensive high school and a second officer at each intermediate school, with ten of those intermediate officers supporting elementary schools.

The intermediate officers who support elementary schools are assigned to two to four elementary schools and they make efforts to visit those campuses periodically during the week or as requested/needed by the elementary principal. The school district also added security monitors to each comprehensive high school. To increase adult visibility at the elementary school level, the District implemented the Watch D.O.G.S. program. This program has been disrupted due to COVID-19.

AN OFFICER AT EACH ELEMENTARY SCHOOL

The 2022 School Safety Advisory Committee, through an importance ranking process, recommends one officer per elementary school while maintaining current law enforcement staffing for intermediate and high schools. The Committee recognizes the staffing and funding challenges facing the school district however, the District must make elementary school security staffing a priority. The school district should continue to foster partnerships with local law enforcement agencies.

SAFETY TRAINING

School safety is not isolated to only law enforcement coverage. The Committee asks that the district improve, and increase the frequency of, mandatory school safety training to staff and students as well as make it available to parents. This training could also include CPR and basic first aid training. The school district has an opportunity to bring a greater awareness of the important role each person plays in keeping schools safe through consistent training.

ACCOUNTABILITY MEASURES FOR STAFF

The group also recommends the District implement accountability measures when safety protocols are not followed by staff. Roles and responsibilities should be clearly articulated in applicable job descriptions, and disciplinary action should result if procedures are not followed.

EXPAND COMMUNITY OUTREACH PROGRAMS

Reinstituting the Watch D.O.G.S. program will increase adult visibility in schools. The Committee discussed the Watch D.O.G.S program and would like to see a significant expansion of it to all schools, clear and consistent training and expectations for volunteers, and a district-wide system of monitoring the impact the program has on school safety.

If the current structure and purpose of Watch D.O.G.S does not serve a distinct safety outcome, the school district should develop its own community safety monitoring program. The Committee believes there is significant interest within the community to serve Clear Creek ISD in this area.

Committee members expressed interest in the school district developing additional community outreach programs such as Meet the Deputy to enhance law enforcement visibility and relationships with students. Many local police agencies already have outreach programs in place which can assist.

IDENTIFYING & RESPONDING TO THREATS

The school district has implemented threat assessment teams at each school. These teams generally comprise of administrators, a counselor, and other persons as needed. The threat assessment process is now required under Texas law. These teams are trained on the threat assessment process, which also includes a student mental health risk assessment/interview.

SIGNS OF CONCERNING BEHAVIORS TRAINING

The CCISD School Safety Advisory Committee is recommending that the school district develop a subset of the threat assessment team training for all employees which should be explicit about the signs of concerning behavior and the importance of reporting concerns to the right person. This training should be required, consistent, and frequent. The committee recommends the training information not be isolated to only annual mandatory training or when an employee is hired.

MENTAL HEALTH EDUCATION AND COMMUNICATION

While the school district has mental health resources available on its website and counselors for students who may be in need of support, the Committee recommends the school district implement a communications plan to better educate students, as age appropriate, and their families about the signs of concerning behaviors, who to report those concerns to, and how to use the Anonymous Alerts System.

There was discussion in the group about the importance of collaboration between parents and counselors, and that parents may not know to call the counselor to share certain concerns about their own child.

The Committee believes mental health education is a key component to a comprehensive safety plan which is why it is recommending the school district create opportunities for families, students, and staff to be educated on the topic of mental health. This can be in the form of in person, online, or hybrid. Many training programs already exist such as Mental Health First Aid. These efforts will also assist in destigmatizing mental health, allowing students to feel it is okay to seek help with their social and emotional needs.

SCHOOL COUNSELING STAFFING

As with officers, the Clear Creek Independent School District significantly increased the number of school counselors specifically to address the social and emotional needs of students following the 2018 school shooting in Santa Fe ISD. Fifteen student support counselors were hired, bringing the total number of student support counselors to two at each high school and one student support counselor to each intermediate school. The CCISD School Safety Advisory Committee is requesting the school district hire additional counselors to meet the needs of students.

TECHNOLOGY AND SECURITY SYSTEMS

Clear Creek ISD has invested more than \$29 million in security upgrades since 2018. Such improvements include access control, intrusion detection, surveillance cameras, classroom door hardware, transaction windows at certain schools, and secure entrance vestibules. Every phone in the district has an emergency button which is directed to the District's emergency dispatch office.

CCISD adopted the Standard Response Protocol which unifies terminology and actions in the event of an emergency. The Standard Response Protocol is now incorporated into the District's new Raptor Emergency Management software. This will further streamline emergency response and communication throughout the school district.

The Committee toured a campus to see how technology enhances school security. This tour included a demonstration of a new capability regarding exterior doors. The District has the ability now to both email and audibly notify staff when an exterior door is propped open for a pre-determined time. This capability will be implemented in the 2022-2023 school year.

MONITORING AND SECURING EXTERIOR DOORS

The Committee recommends the school district continue to utilize advance technology to secure schools. These systems are only effective if consistent training is offered, and implementation is completed with fidelity. The school district, with the involvement of local agencies such as EMS and fire, should conduct a uniform study of each school to identify vulnerable locations. The District should develop individual plans to mitigate any risks identified.

Recognizing the District is in the process of implementing the audible door alarms and notifications for ajar exterior doors, the Committee recommends that a unified system be established to notify staff that a door is propped open, and the roles and responsibilities of staff are clearly communicated. Also, plans should be developed and communicated on how door alarms may need to be adjusted due to large events such as concerts when there are many visitors.

SECURITY PLANS

In the event of an emergency, the Committee is recommending the District add room numbers to the exterior side of the school buildings to assist first responders identifying classrooms that may need assistance upon arrival. If not already in place, the District should share floor plans and offer walkthroughs to first responders so they are familiar with the layout of schools.

The Committee made it clear that they support all efforts to further secure school buildings, however, members do not want school to feel like a prison. Therefore, the Committee recommends schools establish student panels to allow authentic feedback on the school climate and safety stance.

2022 SCHOOL SAFETY ADVISORY COMMITTEE

In conclusion, the Committee shared with the Superintendent and District leadership that they felt supported by one another throughout the process and that their input was valued by the school district. These recommendations have been provided to the Superintendent for consideration. The Superintendent and staff will consider all recommendations and determine what recommendations to make to the school board for any items that require Board approval.







Keycard access for subs/interventionists As a sub/math interventionist, I feel like my students are less safe with me because I do not have access to get them back in the building quickly


Making sure all subs (elementary level) have badges to access exterior doors for recess, etc. It will prevent countless numbers of subs and students having to wait outside to be let inside.
